Chief's Report Building project planning and design are moving forward. Programming has begun for the headquarters remodel. Planning is moving forward on the Ops remodel. The budget has increased due to the change of scope. The revised plan will allow the building to handle future needs. Costs are being reviewed before the guaranteed maximum price is presented to the Board. Discussion regarding funding followed. Construction is slated to start in September.

The Board was presented with the 2026 wildfire outlook report. The District has participated in numerous local wildfire community meetings. There has been a lot of interest from the public about the wildfire danger.

Deputy Chief-Admin's Report Sales tax revenues for May were approximately \$460,000. Staff has found that some local businesses are not able to remit District sales tax to the state and is working with the Colorado Department of Revenue to rectify it.

Training Division Update – May 2026 Joe Dell, Division Chief – Training

Update

This month, our crews did a tremendous job and logged more than **1,500 hours of training**, with **C-Shift leading the way**. The commitment our members continue to demonstrate toward professional development and operational readiness is impressive and directly contributes to the high level of service we provide our community.

Highlighted Training

During May, the Training Division worked closely with the Wildland Division to help deliver the annual Wildland Firefighter Training program and support new hire orientation. These efforts ensured seasonal and newly hired personnel received the foundational knowledge and skills necessary for safe and effective wildland operations. In addition, new employees completed Driver/Operator orientation components, introducing district vehicle operations, driving expectations, and apparatus familiarization.

Shift personnel also participated in the annual Swiftwater Rescue Refresher led by Neal Martin. The training focused on water rescue safety principles, throw bag deployment, victim rescue considerations, river hazard recognition, and operational readiness for the runoff season. These hands-on sessions provided valuable opportunities for members to refresh critical skills and maintain competency in one of the district's higher-risk rescue disciplines.

Keegan Fawley and Tony Magnanini facilitated advanced airway training designed to enhance our crews' ability to care for patients experiencing severe respiratory distress and other critical airway emergencies. The training reinforced advanced airway management techniques, including preparation for endotracheal intubation when necessary in life-threatening situations.

Looking Ahead

Looking ahead to June, the Training Division will focus on Low Angle Rescue operations. Planned training will provide members with hands-on experience in rope rescue fundamentals, anchor systems, patient packaging, mechanical advantage systems, and safe edge operations. This training supports the district's technical rescue capabilities and ensures personnel remain prepared for the diverse rescue incidents encountered throughout our response area.

WHEREAS, the Trust is a statutory trust formed under the laws of the State of Colorado in accordance with the provisions of Parts 6 and 7, Article 24 and Articles 10.5 and 47 of Title 11 of the Colorado Revised Statutes regarding the investing, pooling for investment and protection of public funds;

NOW, THEREFORE, it is hereby RESOLVED as follows:

1. Board of Directors hereby approves and adopts, and thereby joins as a Participant with other Local Governments pursuant to Title 24, Article 75, Part 7 of the Colorado Revised Statutes,

(i) that certain Uniform Resolution Relating to the Establishment of the Centennial State Liquid Investment Pool; and

(ii) that certain Indenture of Trust entitled the Centennial State Liquid Investment Pool as amended from time to time, the terms of which are incorporated herein by this reference and a copy of which shall be filed with the minutes of the meeting at which this Resolution was adopted; and
