STAFF REPORTS

Chief's Report The Operations Building renovation project is moving forward. Meetings regarding the project schedule and pricing are nearing completion, and final dates and costs will be presented to the Board in July. The first phase of land acquisition near Redstone and Marble is also underway.

Seasonal staff are conducting daily patrols. Crews responded to two fires recently, one in Meredith and one along Interstate 70.

Division Chief - Training The Training Division has been very busy with the new hires. Members participated in over 1500 training hours in May.

Division Chief-Wildland Stage 1 fire restrictions are in place throughout much of the district. Vegetation is drying out and other indicators of prime fire behavior have been occurring in the district. Initial Attack patrols are out in both ends of the district daily.

Division Chief-Prevention Crews are working with Heritage Park Care Center on an evacuation drill.

FINANCIAL REPORT

2025 Audit There were no questions or comments on the 2025 Audit.

Sales Tax Sales tax revenues has been above the initial estimate.

Chief's Report & Updates – July 8, 2026

2026 Capital Construction Projects

Station 81 Crew Quarters Remodel

We received the initial pricing for this project in May and, when all scope was included, the total costs were far too high. The two big reasons for this were:

1. The overall design of the project was dramatically changed and this added to the scope of the project significantly. This change occurred after the architectural team received months of gathered input from all 48/96 shift personnel and the District members of the Building Team.
2. Quite a bit of additional scope was added to the project. this additional scope included improvements to the apparatus bays, bay doors, maintenance section along with proposed removal and replacement of both wooden decks and the re-sheathing/re-siding of the original portions on the exterior of the Operations Building.

So, the architectural team, building team and PNCl performed a thorough review and reduction of scope along with seeking solid, aggressive pricing from potential sub-contractors and vendors. All of this work has produced a much better plan that still gives us the excellent design from BG Architectural that will be a facility for the growth and necessary operational space envisioned for the next 20 years.

I am very pleased with the final version and pricing for this project. We are planning on presenting the entire package to you at a **Special Board Meeting on July 15th**. Phil Vaughan and PNCl will be attending the meeting and our architectural team will also be available, if needed.

Marble Workforce Housing Project

The Building Team, Phil Vaughan and BG Architectural have been working for several weeks on a potential existing building in the Marble area to determine the feasibility of purchasing the property along with the necessary conversion of the building to accommodate 5 units of workforce housing. More to come and, we can discuss at the upcoming July meeting.

Station 82 Design and Land Aquisition

We have spoken with 2 different representatives from Pitkin County Open Space regarding the possibility of acquiring property behind the coke ovens along Coal Creek Road. I am not optimistic about this potential opportunity. I have been advised that there are very narrow conditions that may possibly allow a fire station to be built there and, I am not confident that we fit those conditions. Additionally, I was advised about the potential of very negative public response and reaction to a proposal like this.

We are looking at alternatives to this property along the stretch of Hwy 133, directly to the north of the coke ovens area. I am optimistic that we have opportunity there. Hopefully, I will have some additional information regarding this next week.



2026 Wildfire Season

Deployments

So far, the 2026 wildfire season is living up to our concerns and predictions of being an active and difficult year. We have been staffing (daily), two Initial Attack (IA) engines and crews of 3 that both the northern and southern areas of the district.

The anticipated potential for regional and national wildfire deployment requests have come to fruition early in the summer season. We currently have a Tactical Tender and crew deployed to the Aspen Acres Fire. The tender and crew are part of a structure protection group as of this writing (7/2/2026).

Additionally, we have responded to several neighboring and regional wildfires. Our crews recently responded to a MAMA request to the Dry Creek Fire, near Rifle, the Red Rock Fire, west of DeBeque, The Snyder Fire, west of Fruita, the Spring Creek Fire, in the White River National Forest, and now the Aspen Acres Fire, near and in Beulah, Colorado.

All of this is in addition to multiple responses to wildfires in the District and in our Automatic Aid fire districts to the east and to the west. So far, we have been able to Keep Small Fires Small. Hopefully, this trend will continue.

We will respond to any requests for engines and crews as we always have. If we have the staffing in place in the District and fire conditions in our region allow for it, we will respond to requests for assistance.

Administrative

- The Wildland Division successfully completed its inaugural seasonal hiring process, employing 16 seasonal personnel to support district operations.
 - 10 fully qualified wildland firefighters.
 - 6 dual-role/single-role personnel supporting operational and staffing needs.
- CRFPD conducted an in-house NWCG S-130/S-190 and L-180 Firefighter Type 2 (FFT2) academy for seasonal personnel and volunteer members, resulting in all participating personnel achieving the minimum NWCG qualification of Firefighter Type 2 (FFT2).
- Division Chief Deter has actively participated in numerous community outreach and public education initiatives focused on increasing public awareness of the growing wildland fire threat facing the District.
- The Wildland Division, in collaboration with the Administration and Prevention Divisions, has made significant progress toward establishing a comprehensive wildland mitigation program and associated cost recovery process.
 - Developed a mitigation billing structure for future mitigation projects.
 - Purchased specialized mitigation equipment that was not previously available within the department.
 - Initiated the transition of B83 from frontline emergency response to a dedicated mitigation vehicle, when operationally appropriate.
 - Developed internal scheduling and project tracking procedures to improve customer service and project completion.
 - Worked collaboratively with Chief Cutright to establish billing practices and administrative procedures for mitigation services.
 - Established a coordinated workflow in which the Prevention Division conducts home assessments, mitigation assessments, and project estimates, while the Wildland Division performs mitigation operations.
 - This division of responsibilities is intended to reduce duplication of effort, improve interdivisional communication, and enhance operational efficiency.
- The Wildland Division has consistently staffed two initial attack (IA) patrol units, each with three personnel, providing enhanced wildland response capability throughout the District during periods of elevated fire danger.
- Seasonal personnel have also supplemented daily shift staffing, improving operational readiness while helping maintain minimum staffing levels.
- Division Chief Deter has been working collaboratively with neighboring agencies, including Glenwood Springs Fire, Roaring Fork Fire Rescue, and Aspen Fire Protection District, to develop a standardized regional wildland fire response framework. Current efforts include:
 - Establishing common terminology and communications.
 - Standardizing operational strategies and tactical objectives.
 - Evaluating agency capabilities and operational limitations.
 - Identifying high-risk areas and developing coordinated pre-incident plans.

- Exploring the development of a regional Strike Team/Task Force concept to improve interoperability throughout the Roaring Fork Valley.
- The Wildland Division requested and completed an Incident Qualification System (IQS) audit to identify qualification and data management discrepancies and improve compliance with NWCG PMS 310-1 qualification standards.
 - Montana Arsenault has been offered as tribute to complete this task that I am greatly looking forward to.
- Significant progress has been made toward ensuring CRFPD personnel – including career, volunteer, and part-time members – are equipped with appropriate wildland personal protective equipment (PPE). Accomplishments include:
 - Purchase of modern wildland fire packs.
 - Purchase of additional wildland protective clothing (greens and yellows).
 - Purchase of additional NFPA-compliant wildland boots.
 - Replacement of more than 50 expired wildland fire shelters, substantially improving firefighter safety and regulatory compliance.
- The Wildland Division provides a more comprehensive opportunity for developing and maintaining wildland qualifications throughout the organization. Long-term objectives include:
 - Increasing the number of qualified Firefighter Type 1 (FFT1) and Incident Commander Type 5 (ICT5) personnel.
 - Expanding the department's Engine Boss (ENGB) cadre from six qualified personnel to twelve.
 - Developing qualified Strike Team Leader (Engine) (STEN) and Task Force Leader (TFLD) personnel.
 - These qualifications will not only expand CRFPD's operational capabilities during large wildland incidents but also strengthen incident command capacity and firefighter safety throughout the Roaring Fork Valley.
- Since its establishment, the Wildland Division has responded to numerous wildland incidents throughout the Roaring Fork Valley, providing assistance from Aspen to Rifle. Most recently, through the Mutual Aid Mitigation Agreement (MAMA), CRFPD deployed a Tactical Tender to the Snyder Fire, which was subsequently reassigned to the Aspen Acres Fire.

Training Division Update – June 2026

Joe Dell, Division Chief – Training

Update

June was another productive month for the Training Division as crews continued to build skills through hands-on training while supporting several regional training initiatives.

Highlighted Training

Shift personnel completed Low Angle Rope Rescue training, reinforcing the fundamentals of rope rescue, patient packaging, anchor systems, and safe operations at the edge. The hands-on training strengthened both technical skills and teamwork.

The Training Division continues to strengthen its partnership with Colorado Mountain College (CMC) through collaborative training initiatives that benefit both organizations. This month, CMC took delivery of a new Bauer SCBA compressor, which will be housed in our apparatus bay under our partnership agreement. While the compressor is owned by CMC, Carbondale & Rural Fire Protection District will maintain the equipment and utilize it to support both department operations and regional firefighter training.

We also partnered with the All Valley Training Consortium to host a Fire Instructor I course, providing certification opportunities for instructors from across the region.

Carbondale additionally hosted the Colorado Driver/Operator Utility State Practical Exam, where seven members successfully earned their Driver/Operator Utility certification. Congratulations to everyone who completed the process.

Looking Ahead

In July, shift training will focus on Thermal Imaging, emphasizing effective camera use during fire attack, search, overhaul, and size-up to improve firefighter safety and fireground decision-making.

Planning is well underway for the upcoming Firefighter II class, which will be hosted later this summer through the All Valley Training Consortium.
